Subject: FDA and AFDO Partner to Award Year 2 Grants to State, Local, Territorial, and Tribal Regulatory Retail Food Programs

Dear Colleague,

The U.S. Food and Drug Administration (FDA) and the Association of Food and Drug Officials (AFDO) are proud to announce Year 2 of the AFDO administered Retail Program Standards Grant Program. Opening on Monday, September 2, 2014 and accepting applications through Friday, October 10, the program provides funds for the completion of projects and training to enhance conformance with the Voluntary National Retail Food Regulatory Program Standards (Retail Program Standards). Grant funding is open to state, local, territorial, and tribal regulatory retail food programs that have enrolled in the [Retail Program Standards](#). Applicants to this program can expect a simple application process, up-front funding when required by the project, and simple reporting requirements.

Funds are available for completing projects that meet Retail Program Standard goals and objectives in three categories:

- **Category 1: Small Projects (up to \$3,000)** - Examples: Completion of Self-Assessments, Verification Audits, Small Projects that help advance or maintain conformance with one or more Standards
- **Category 2: Moderate Projects (\$10,000 to \$20,000)** - Examples: Completion of Foodborne Illness Risk Factor Studies, Implementation of Comprehensive Intervention Strategies to Reduce Risk Factors, Moderate Projects that help advance or maintain conformance with one or more Standards
- **Category 3: Training (up to \$2,000)** - Examples: Travel to training courses, workshops, and seminars that advance the goals of the Retail Standards Jurisdictions that applied and/or were awarded funds in Year 1 are eligible to apply again for funds in Year 2.

Jurisdictions can apply for funding for one project in each of the three categories for a maximum of three applications per jurisdiction. The amount of \$502,500 in funding is available for Year 2 funding, and we expect to make 140 awards or more annually through this program. Jurisdictions must be enrolled in the Retail Program Standards in order to apply.
